Southern Illinois Healthcare Enterprises Inc supports the exempt purpose of Southern Illinois Hospital Service (SIHS), EIN 37-0618939 Southern Illinois Healthcare Enterprises, Inc owns and maintains facilities which are used to deliver healthcare Program service revenue is fees from tenants which in total are leasing approximately 121,000 square feet of medical space This medical space is used to deliver healthcare throughout Southern Illinois regardless of race, creed, sex, national origin, handicap, age or ability to pay The facilities owned and operated by Southern Illinois Healthcare Enterprises, Inc are used to deliver healthcare services to a seven-county region with a combined population of 240,077 These counties are very rural Populations per square mile range from 37 to 144 persons per square mile compared to a state average of 223 per square mile Collectively, the residents of each of these counties have median household incomes that range from 25 47% to 46 46% below the statewide average of \$46,590 More of the residents of these counties live in poverty that the state average of 10 7% with the highest percentage county being 25 2% and the lowest county being 11 3% Five of these counties also rank among the poorest of Illinois' 102 counties based upon the percentage of children living in poverty These five counties are ranked at 98th, 97th, 92nd, 89th, and 83rd The tenants leasing these facilities from Southern Illinois Healthcare Enterprises, Inc offer a wide range of healthcare services Family practices, internal medicine, surgeons, along with several specialty practices are represented by these healthcare providers These facilities enable healthcare to be provided to individuals under uncompensated government-sponsored programs and charity care to those unable to pay These facilities also enable us to continue to educate the community about healthcare by providing information about the Community Benefit programs of Southern Illinois Hospital Services to their patients
